## Highlights of 2008 CAERDA International Conference from Conference Chair Dr. Chuang Wang

Dear CAERDA members and friends,

The 16<sup>th</sup> annual international conference was held in Crowne Plaza Hotel in New York City on March 23-24, 2008. The theme of this conference was "East Meets West: The Role of Chinese Culture and Language in Global Education." The program included 1 keynote speech, 2 invitational panel sessions, 7 panel sessions, 12 paper sessions, and 5 interactive sessions. Dr. Duc-Le To, President of CAERDA, opened the conference with an introduction of the keynote speaker, Dr. Shuhan Wang. Dr. Wang is Executive Director for the Chinese Language Initiatives at the Asia Society and the author of numerous books in Chinese language acquisition. The topic of her speech was "Chinese Language Education in the U.S.: A Historical and Ecological perspective." Her speech gained high appreciations of the audience.

Two groups of renowned scholars were invited for panel sessions as well: Professors Maria Tu, Rujie Wang, and Jianguo Chen focused on the politics of Chinese films in the context of globalization. Professors Jinfa Cai, Steve Chi-Yin Yuen, Kenneth Wong, and Kit-Tai Hau focused on insights and recommendations for publishing in peerreviewed journals. Both sessions were warmly welcomed by CAERDA members.

The panel, paper, and interactive sessions included a total of 134 presentations from scholars in the United States, Mainland China, Taiwan, Hong Kong, Singapore, Great Britain, and Canada. The topics of these presentations covered such fields as teaching and learning Chinese language in the United States, teacher education and school policy, cultural diversity and awareness, assessment in Chinese language achievement, instructional technology, parental involvement, bullying, and counseling in education. Presenters' background is diverse: it varied from prestigious international scholars to high school students. Quite a few presentations were co-authored by professors and their graduate students: the critical mentoring process for the future of our community. The conference ended with 2008 Outstanding Dissertation Award. The award went to Dr. Shu-Huei Yen for her dissertation about teaching Taiwanese indigenous students.

As a tradition to welcome new members and have a get-together with old acquaintances, a dinner banquet was held at China Regency Restaurant on the 7<sup>th</sup> Avenue of Manhattan. Over 100 CAERDA members as well as their family members and friends attended the banquet. Some people joined the association and made donations to the association at the banquet.

The 16<sup>th</sup> CAERDA international conference would not be made possible without the hard work of the 2008 Conference Planning Committee and all conference participants. Special thanks also goes to the Cheng & Tsui Company who provided door prizes and book discounts to CAERDA members.

## Welcome New Board Members from Former CAERDA President Dr. Duc-Le To

The CAERDA Board made two important decisions this Fall. First, the Board elected four new members: Dr. Lusa Lo, Dr. Youmei Liu, Dr. Ya-yu Lo, and Dr. Jennifer Chen. It also elected Dr. Chuang Wang as the new President, Dr. Youmei Liu as Vice President, Dr. Ya-yu Lo as Treasurer, and Dr. Yann-Yann Shieh as Secretary. In addition, the Board also filled three vacant staff positions. It appointed Dr. Aubrey Wang (Saint Joseph's University) as the new Controller, Dr. E. Sheen (Florida State University) as the new Webmaster, and Dr. Wei-Ming Luh (National Cheng Kung University) as the new Regional Membership Director for the Taiwan Region. The Board also created a new staff position, AERA Liaison and appointed Dr. Aubrey Wang for the new position. Second, the Board released the Call for Proposals for the 2009 CAERDA Conference and appointed Dr. Youmei Liu as the Conference Chair. (See the Call for Proposals in this newsletter.)

The Board thanks the four outgoing members, Dr. Aubrey Wang, Dr. Allen Huang, Dr. Leigh Wang, and Dr. Chenling Chou for their leadership and significant contribution to the Association during their term as CAERDA Board members. The following are brief introductions of the new board members.

## Dr. Lusa Lo is an Assistant Professor in the

Department of Curriculum and Instruction, Special Education program. She teaches Consultation and Interpersonal Skills, Standardized Assessment for Students with Disabilities, Inclusive Interdisciplinary Curriculum Development Building, Collaborative Partnerships with Families of Children with Disabilities, and Capstone Research Seminar. Her research interests include familyschool-community partnerships among the Chinese population and assessment of culturally and linguistically diverse learners in special education.



 $\mathcal{D}r.$  Youmei  $\mathcal{L}iu$  works in the Division of Educational Technology and University Outreach at the

University of Houston. She develops faculty training programs, and provides professional consultation related to quality course design and effective integration of instructional technology. Her research interests cover faculty development, academic assessment, instructional technology evaluation, cross-cultural online learning, development of learning communities, and the integration of instructional technology in teaching and learning.



Dr. Ya-yu Lo is an Assistant Professor in the Department of Special Education and Child Development at the University of North Carolina at Charlotte. Her interests and expertise are in the areas of functional behavioral assessments, positive behavior supports, social skills instruction, urban students at-risk for behavior disorders, and applied behavior analysis. She has extensive work with children and youngsters with challenging behaviors for over a decade, including two years of consultancy with delinquent juveniles under probation. She is the current Managing Editor for *The Journal of Special Education (JSE)* and the Vice President of the North Carolina Association for Behavior Analysis (NCABA).



*Dr. Jennifer Chen* is an Assistant Professor of Early Childhood and Family Studies at Kean University. Upon earning her doctorate in Human Development and Psychology from Harvard University Graduate School of Education, she received an Outstanding Dissertation Award from Phi Delta Kappa International. She is founding co-editor of *Journal of School Connections*.



# Current Status and Directions of Changes to New Waves Journal of Educational Research and Development from Dr. Chuang Wang

### **Current Status**

*New Waves Journal of Educational Research and Development (New Waves Journal)* was a quarterly on-line journal by the Chinese American Educational Research & Development Association (CAERDA). It was printed on paper and sent to our members free of charge until 2007 due to financial constraints. It was approved by CAERDA Board at a meeting on April 7, 2007 in Chicago to re-position the journal, improve the quality of submissions, and expand its readership. To save cost on printing and distributing the journal, the Board decided to move the journal to internet-based (on-line) only. The Board also recruited an Editor-in-Chief but the person declined the offer. Later, Chuang Wang agreed to serve as the Interim Editor-in-Chief. The Board also suggested that we should start slow with one or two issues each year.

Since March 2007, we have received 15 submissions, 8 were rejected, 2 are currently under review, and 5 were accepted for publication in March 2009.

### **Direction of Changes**

A focus group discussion was conducted at the 2008 CAERDA conference site in March 2008. A summary of proposed changes to the journal was prepared by Chuang Wang, the Interim Editor-in-Chief, and presented to the Board. The Board had an in-depth discussion on the future of the journal via exchange of emails in October 2008 and voted on suggestions to improve the quality of the journal. The Board made the following decisions:

- 1. Recruit Dr. Wen Ma, Associate Professor at Le Moyne College, Syracuse, New York, to serve as the Associate Editor for the March 2008 issue. The Board will recruit one Editor-in-Chief and two Associate Editors for future issues. Each of the two Associate Editors will serve two years.
- 2. The journal will be published on-line and in English only. This means manuscripts written in Chinese will not be accepted for review. This is mainly because of the difficulty to find reviewers who have expertise in related fields and fluent in either traditional Chinese characters or simplified Chinese characters.
- 3. The journal will keep the tradition of publishing papers of all areas, not just Asian/Chinese American education, and the tradition of publishing both empirical studies and policy papers. More preference will be given to papers based upon empirical studies. Guidelines for authors will be posted on CAERDA website.

## CALL FOR PROPOSALS

The Chinese American Educational Research and Development Association (CAERDA) warmly extends the invitation to solicit proposals for presentations at its 2009 International Conference on April 12-13, 2009 in San Diego, California, U.S.A. This annual event, held in conjunction with the American Educational Research Association (AERA), provides an exciting opportunity for educators, researchers, and policy makers from around the world to engage in scholarly exchange and invigorating dialogue on issues related to educational excellence and equity, particularly among Chinese and Chinese Americans.

The theme for the 2009 CAERDA Conference is "*Educational Technology: Enhancing Teaching and Learning with Technology in the 21<sup>st</sup> Century.*" Technology has redefined our educational processes and social structure. To better prepare students to meet the demands of this technologically advanced era, teachers and educators alike must consider the role of technology in facilitating learning and fostering cross-cultural understanding. While technology has been used in diverse learning environments and disciplinary areas to enhance instruction, more efforts are needed to understand a range of issues from the integration of new technologies to the assessment of their effectiveness. At this conference, we are particularly interested in research related to (a) the use of educational technology with the focus on Chinese or Chinese American students, and the Chinese culture or language; and (b)

international studies that compare educational technology usage across different cultural, linguistic, ethnic, or socioeconomic backgrounds (e.g., comparing students and schools in the U.S. with those in China, Taiwan, and Hong Kong). Within this broad conference theme, the conference will focus on the following sub-themes:

**Sub-theme 1:** Enhancing teaching and learning through the use of technology (e.g., digital story, automated reading tutor, using computers in Chinese language instruction);

**Sub-theme 2:** Assessing the effects of using technology for instruction and learning (e.g., assessment of technology accessibility, assessment of student academic achievement or social competence, evaluation of educational computer software);

**Sub-theme 3:** Promoting effective technology use in distance or online learning (e.g., e-learning in foreign language, online AP courses in rural schools); and

**Sub-theme 4:** Examining policies and other issues related to educational technology beyond the classroom (e.g., digital divide, technological infrastructure, computer security, Internet safety for children).

In keeping with the CAERDA conference tradition, we also welcome studies on other areas of research and practice that may not directly relate to the conference theme but contribute to the understanding of important educational issues in the 21st century.


